Damage of any kind caused by the animal(s) will be completely rectified at the Tenant's cost, prior to vacation of the premises.			
The Tenant accepts full responsibility for any animal that the Tenant brings or allows upon the rented premises with or without the consent of the owner/agent and will be solely liable for all loss and damage or injury suffered by any person who is attacked by any such animal. If any action is brought against the owner/agent by any person, despite the resident being responsible, the resident will indemnify and hold harmless the owner/agent from any claim, action, suit or demand brought against it/them by any person injured by such animal.			
The Tenant further agrees that is the animal(s) subject to this agreement becomes a nuisance to neighbours, or a genuine complaint(s) is received regarding the animal, the Tenant will upon request from the agent immediately remove the pet from the property permanently without limiting or voiding existing lease obligations. The tenant will also observe and comply with any additional Owners' Corporation rules.
